The Friends Archive Moved

The Spring 2011 Caucus told the sad story of the Friends declining finances that was forcing the archive to move to a less expensive site. The next chapter can now be told.

Discussions with the George Washington University Library, Special Collections Research Center resulted in their agreement to accept the entire Friends Archive. I spent the entire month of July in the archive, with some hired clerical help, sorting, organizing, labeling and packing materials. On July 29, a GWU truck picked-up 150 boxes from the large room of Friends archive.

Some readers may know that in 1964 I began gathering materials for what became the Friends archive while serving as an intern at FMCS national office in the old DOL building. I spent a lot of time in the DOL library learning about and copying documents on the USCS and early FMCS. During the 47 years since, as the content of the archive grew, I became attached to the materials. So as the GWU workers removed the 150 boxes, leaving the 18 by 20 room completely empty, I felt a lost similar to my sons leaving home.

I kept the smaller 8 by 9 archive room, which is packed, floor to ceiling, leaving only space for one chair. The good news is the monthly rent declined from \$625. to \$150. I want to thank those readers who donated money, in large or small amounts, to keep the Friends archive going since 1995 when I moved it from the basement of my house to rented space.

It will be months before the 150 boxes of material at GWU will be completely processed, cataloged and ready for researchers and displays.

National Office News

Director **George H. Cohen** and Deputy Director **Scot Beckenbaugh** have gotten much media coverage on their mediation efforts with National Basketball Association and NBA Players Association. This media coverage, and that following their work on the National Football League negotiations, is very positive for FMCS. That it particularly true when contrasted with the negative attention the NLRB is getting.

On May 25, 2011, Director Cohen issued the following statement to the FMCS staff:

As you know, ever since Executive Order 13522 was promulgated In December 2009, I have been actively engaged in a program emphasizing the various types of assistance FMCS mediators can offer to help achieve labor-management collaboration throughout the Federal Government. The first phase of our activity was focused on conducting training sessions together with the Federal Labor Relations Authority in which our mediators jointly trained Agency representatives and their union counterparts concerning the nuts and bolts of how to establish labor-management forums and then to utilize them on a collaborative basis. To date, we have conducted more than 200 training sessions with at least 50 mediators participating. Thanks to your efforts, I have received uniformly positive responses from the numerous federal agencies and their bargaining representatives concerning this aspect of our activities.

I am now pleased to report the next innovative phase: at our behest, the National Council on Federal Labor-Management Relations has announced the creation of a "Training the Trainer" program. The program is being designed so that upon the joint request of an agency and its bargaining representatives the FMCS will provide a mediator to conduct training in which the parties are jointly instructed on how they, in turn, can train other members of their respective organizations in how to conduct the forums. This is a much-needed development as it will expand the pool of available trainers and help facilitate training of the extraordinarily large number of local labor-management forums, particularly at agencies with multiple bargaining units. In anticipation of this important new initiative, Heather Butler, Director of Education and Training, has established an e-room so that mediators assigned to conduct the training will have access to the latest training materials.

A surprise contribution of \$1,486.52 came from a 501 C 3 account created years ago by a long time friend named Hugh Jascourt. The account was forgotten after Hugh's death several years ago. By calling them mediators it confines their work to the world of conflict. The strength of the neutral party is not in mediating or resolving conflict, but in making connections between people. By doing that, they open up a huge new vista of possibilities --- more akin to the PM work, but even much broad, maybe they will have a Director one day to push them there."

After lunch last month with **Jerry Ross, Nick Fidandis, Tom Colosi** and myself, Jerry Ross reminded us of a **Dave Tanzman's** training tools. Some readers will remember Dave's "nine dots" exercise, which encouraged out-of-the-box thinking. Jerry showed us Dave's illustration of why labor-management cooperation must involve not just labor and management, but employees as well. The illustration starts with an equilateral triangle with the word labor, management, and employees each written near one of the angles. The illustration shows each party equal distance from the other two, but when two parties move closer together without moving closer to the third party, the shape of the triangle changes to the detriment of the third party. Dave's point is balance is significant in relationships.

In Memoriam

In October 2011, former Commissioner **Buford G. Thompson** died. Buford was a mediator in Kansas City from October of 1975 until he retired in January 1996. With his wife of 65 years, Buford had six children and seven grandchildren.

Karen Kline, age 52, died on July 6, 2011. For five years, she served as Deputy General Counsel and as a mediator in Baltimore.

On April 8, 2011 former Commissioner **Al Kapner** died at age 87. He initially served in Chicago and later in Philadelphia. Two daughters, a son, and seven grandchildren survive him.

Former Commissioner **Jack Healy** died on April 3, 2011 at age 61. Jack spent 30 years with FMCS in Boston and Worcester, retiring in 2006. Healy began his career as a intern.

On September 12, 2011, former Commissioner **Dave Thorley** died at age 74. He joined FMCS in 1975, serving in Cleveland and Akron, retiring in 1999. Dave had four daughters, ten grandchildren and five great grandchildren.

On December 31, 2010 former Commissioner **Floyd Wood** died. Floyd's FMCS service included Regional Director in Los Angles and Deputy National Director.

On June 21, 2011, Commissioner **Clarence Washington** died at age 85. He joined FMCS in 1965 and served in the San Francisco area until retiring in 1995.

In June 2011, former Commissioner **Tim Sullivan** died at age 89. He served as mediator in California.

John Truesdale began his career in 1948 with the NLRB as a Field Examiner in Buffalo, and rose to become Executive Secretary of the Board for 20 years. He also served several times as a Board Member. Mr. Truesdale died at age 89 on July 3, 2011. He is included in the Caucus because he played an important role in gathering FMCS history. He interviewed Cy Ching, the first FMCS Director, a task that involved nineteen sessions between 9-29-1965 and 12-13-1967. Copies are in the Friends Archive now at George Washington University.

How Things Have Changed or Have They

In the early 1960s, my oldest brother got elected Recording Secretary of Local 36 of IUOE in St. Paul, Minnesota. His predecessor gave him the meeting minutes beginning with the local's first meeting in May 1900. My brother loaned the minutes to me to read. After reading them, I wrote a published article based on them.

One of the most interesting stories I discovered in the minutes involved a local member who was charged with keeping a non-union horse in his barn.

The accused was ordered to appear at the next membership meeting to answer the charge. He attended and admitted a non-union horse was in his barn, but he explained that horse once belonged to him, and when he could no longer afford to feed the horse, he sold the horse to his neighbor, a non-union teamster. But, because he loved that old horse, he allowed the horse to continue to stay in his barn where he could visit the horse. A membership vote found him guilty and fined him a box of cigars, to be delivered to the chairman at the next union meeting.

The minutes do not provide any hint of members' soul searching over their vote to convict and the prospect of a free cigar.
