New Director Sworn-In

George H. Cohen was sworn in as the 17th FMCS Director on October 8, following Senate confirmation on October 5. He had been nominated by President Obama on July 6.

Mr.Cohen has had an extensive and distinguished career as a labor lawyer, negotiator, and mediator. During the period 1966-2005 he was a senior partner at Bredhoff & Kaiser, a Washington, D.C. law firm with a national practice, specializing in representing private and public sector labor organizations in collective bargaining involving a wide variety of industries and government entities. Prior to entering into private practice, the Director served as an appellate court attorney with the National Labor Relations Board. He is a graduate of Cornell University and its Law School and earned a LLM degree from Georgetown Law. In the past three years he has been engaged in a solo practice as a mediator. He is a member of the prestigious Mediation Panel of the U.S. Circuit Court of Appeals for the D.C. Circuit and has successfully mediated numerous, complex, high-profile disputes. From the mid 1970's thru 2005, the Director was an Adjunct Professor at Georgetown Law School where he taught the Art of Collective Bargaining and other labor courses.

In Memoriam

Former Director **Wayne Horvitz** died in June at age 88. Wayne's family conducted a memorial for him on September 20, 2009. The memorial included remarks of fond remembrance, and music and songs by the Horvitz family.

Jane Wolf, a long-time member of the National Office staff, will be remembered by old-timers as a helpful HR person. Jane died on July 26, 2009 at age 82 after a long illness. A veteran of the old United States Conciliation Service (USCS), Jane began working for the USCS in 1943. When FMCS was created in 1947, the entire USCS staff was transferred to the FMCS. Jane remained with FMCS until retiring in 1979. Another long-

time National Office staff member, **Ann Money**, a friend of Jane, said Jane began working at USCS at age 16.

If you think mediation is a new profession, you are erroneous; it began when a human for first time was asked by others to mediate a food dispute.

If you feel the need to read mediation books to become a mediator, you are disoriented; mediation existed long before books were even invented.

If you consider that mediators require specialized education, better ask in which university a four year old girl learned to facilitate a dispute between her siblings.

If you guess that present mediators are better prepared than past mediators, you are missing the point; mediators are always insufficiently prepared..

A couple went to mediation and told the mediator: We decided to end our business partnership, but we don't agree how to do it.

The mediator responded: Do you still have feelings for your partner? Were you ever really partners? Are you truly ready for separation or are you just threatening? Is this a sincere decision based on self awareness or is it only emotion? What is your intent in wanting separation? Have you resolved your internal conflict over the separation? What are your possible interests and outcomes? Did you abandon your initial positions? What do you really want from this? What could be some of the options of agreement? Where are the points of agreement? What is your Plan B and Plan C? What is your worst case scenario? Are you willing to take control of your life in a responsible and mature way? What are your intended outcomes and interests? What are some possible external standards? Can you handle the unpleasant consequences of this separation? What is your game plan? Why should you hire me?

For different reasons the mediator, the lawyer, the psychologist, the priest and the psychiatrist are paid for the same job: the mediator for the parties solving the conflict, the lawyer for administering the conflict of the parties, the psychologist for possible causes of the conflict, the priest for asking God's assistance to solve the conflict, and the psychiatrist for the prescription to the pharmacist.

Martin Wagner: A Labor-Management Pioneer *

Martin Wagner, labor arbitrator, university leader and influential scholar died on June 19, 2009. At age 97, was one of the last living founders of IRRA.

Professor Wagner served as director of the Institute of Labor and Industrial Relations (now the School of Labor and Employment Relations) University of Illinois, Urbana-Champaign, from 1958 to 1968. He retired as professor in 1982. Wagner played a central role in developing Illinois public employee labor relations law, serving as first chairman of the Educational Labor Relations Board.

Early in his career, Wagner served in the WWII Office of Production Management and as a NLRB regional director in San Francisco and Cincinnati. In 1948, he served as the founding executive director of the Louisville Labor-Management Committee, the nation's first area labor-management committee. Prior to his

death, he was notified that he would be recognized for the LERA lifetime achievement award in January 2010. He was also recognized recently for 50 years of service in the National Academy of Arbitrators (NAA)..

At the School, Wagner launched one of the early doctoral programs in industrial relations in 1966. He was beloved by former students and colleagues alike and is seen as having provided the core "dna" for the Illinois program.

Wagner earned A.B. and M.A. degrees at University of Michigan in 1933 and 1935 respectively. He was a Rhodes Scholar (Magdalen '36), earning a B.A. from Oxford University in 1937 and later an M.A. from Oxford in 1960. At the 100th anniversary celebration of the Rhodes Scholar program in 2003, Wagner was the third oldest recipient in attendance.

Successful mediators build trust with the parties by being both impartial and empathic. However, being seen as empathic to one side causes the other side to question the mediator's impartiality. Thankfully, the researcher discovered and shared a solution: engage in impartiality in joint sessions and empathy in caucus. Remember you heard it here first.

(ACR is the successor to SPIDR, the group FMCS played a major role in creating in the early 1970s. Your editor has written over 20 articles for the ACR's quarterly magazine, ACResolution, during the past four years on ADR history, including some on FMCS and USCS.)
