# Announcement: FMCS Commissioner Appointed New Agency Acting Director

#### **New FMCS Director**

**WASHINGTON, D.C.** -- FMCS Commissioner Richard Giacolone has been appointed by President Trump to serve as the Acting

Director for the Federal Mediation and Conciliation Service (FMCS), effective immediately.

Mr. Giacolone began his mediation career at FMCS in the Chesapeake, Virginia field office in 1995. He was the former Director of the FMCS International/ADR Department and Special Assistant to the Director of FMCS. Prior to receiving his commission with FMCS, Mr. Giacolone was Labor Relations Advisor

for the Department of the Navy and has an extensive background in labor relations representing management.

During his 23-year FMCS career, Mr. Giacolone mediated thousands of domestic labor and employment cases, comprising many cases of national significance, ranging from labor disputes involving multiple symphonies and orchestras to bus and transportation disputes and scores of cases involving shipbuilding and repair industries with national impact. He has also mediated numerous significant collective bargaining agreements covering nationwide bargaining units in the Federal sector. His international experience at FMCS includes both mediation and the development and delivery of dispute resolution programs in some fourteen countries.

Among his professional honors, Mr. Giacolone was awarded the Meritorious Civilian Service Medal for his contributions to the Department of Navy Labor and Employee Relations program and the Society of Federal Labor and Employee Relations Professionals Lifetime Achievement Award. He was elected National President of the Society of Federal Labor-Management Relations Professionals.

Mr. Giacolone holds a Bachelor of Science degree in Industrial Psychology and a Master of Public Administration degree from Old Dominion University in Norfolk, VA. regularly lectured at a number of universities on topics such as collective bargaining and arbitration.

### **Some thoughts on This Appointment**

In the Spring 2018 Caucus, I reported: "The White House announced its intention to nominate Michael Stoker, a management labor lawyer from California. He has worked as a neutral for the California Farm Labor Law Board."

Obviously, that didn't happen.

Richard Giacolome is the only FMCS mediator to receive a presidential appointment as Acting Director. Others have become Acting Director based on an outgoing Director appointing his Deputy as Acting Director. The list of individuals who became Acting Director via that route is long, including: Ken Moffett, Scott Beckenbaugh, Jim Searce, Bob Baker, Brian Flores, and Allison Beck. (Can you name anyone else?

Two former mediators, Ken Moffett and Richard Barnes, received presidential appointments as Director. See my post on my website blog on this topic.

On September 6, 2018, I had a long conversation at the National Office with the new Director. I was pleased to learn that Richard Giacolone has a strong interest in FMCS History. That's got to be good from my perspective because not all Directors have shown such interest.

You will notice the FMCS Seal appears on page one of this Caucus. I hope the Seal there doesn't get me in trouble. After using the Seal on my website for a number of years, the FMCS General Counsel sent me a very stern warning about the consequence of misappropriating the Seal.

On his own initiative, my web designer had put the FMCS Seal on my website. When I told him of the warning, he removed, and replaced it with a more colorful one. Check it out at mediationhistory.org.

#### **Two Obituaries**

Retired Commissioner Ansel Garrett passed away on May 1, 2018 at age 83. Ansel began with FMCS (1970-2001) as a field mediator in Birmingham and later Atlanta. He served as Assistant Regional Director in charge of training of New Mediators and PM for Mediators. Prior to joining FMCS, he was the Personnel Manager for Westinghouse. Commissioner Garrett was one of the founders of Georgia Labor Management Conference which promotes Labor-Management Relations. Ansel served in the US Army. He will be remembered for his wit, wisdom and kind, generous heart.

Retired mediator Constance (Connie) Weimer passed away on May 10, 2018. Connie joined FMCS in 1984 and served in Portland, OR and Minneapolis. Connie earned a BA at University of North Dakota and an MA at U of Minn. She taught high school and joined the Teachers Union. Later she worked for the American Nurses Association in Minnesota, Kansas City and Oregon. Connie returned to Minneapolis to work for the teacher's union, and ultimately was hired by FMCS. # **Oral History Release Forms Signing**

Release forms signed by the person interviewed are necessary so the content of an oral history interview can be used by individuals other than the interviewer. Without a signed release, no one but the interviewer can use the content of the interview.

# **FMCS Mediator Interns and Other Untypical Hires**

Traditional FMCS used its own hiring process separate from the Civil Service process that other Federal Agencies used, thus allowing FMCS to manage mediator hiring so as to fit the unique skill set required. For many years, new mediators were hired in groups based on minimum of seven years of labor-

management experience at the GS-12 level.

Another more informal and less used practice existed in which less experienced individuals were hired who were viewed as having the potential to develop into a good mediator after an intern period of growth.

No further information was available from FMCS.

My intern experience in the National Office in 1964 was so unplanned and left to my own initiative that I was able to spend hours in Old Department of Labor Library<sup>1</sup> where I learned about the USCS and the early history of FMCS. When I was transferred to Milwaukee, I carried a box of history material that I had copied in the DOL Library. That boxful became the beginning of my collection, which is now at George Washington University occupying 136 shelve feet.

After five years in Milwaukee, I left FMCS to head an office in DOL for three years where my boss reported to Bill Usery. I did several things that got Bill's attention, which I wrote about elsewhere. When Bill was appointed FMCS Director, he asked me to return to FMCS to head a new office of Technical Services. After he described the functions of the new office, he asked me if I had one thing I would like to accomplish at FMCS. I told Bill I would like to develop an intern program that would recruit, hire and train younger, minorities and female mediators.

Usery, always fond of new ideas, agreed. The result of that agreement was:

The case can be made that hiring five women mediator interns in 1975 opened the door for more women to join FMCS. Here is what happened:

Twenty-one years after its creation in 1947, FMCS hired the first woman mediator in 1968. Ten women mediators were hired at normal entry level between 1975 and 1977. In the 1980s, twelve more women were hired, and in the 1990s, twenty-one more were hired. By 2016, four of the ten FMCS Regional Offices were headed by a woman. The General Counsel and the Director were both women. In that year, twenty-eight percent of the 165 FMCS mediator staff were women.

## **Final Thoughts**

On December 29, I will be 86. Are there any readers older than that? Who are they?

At my age, I still enjoy writing and researching on FMCS history topics, but some encouragement and acknowledgement would be welcome. For example, I often write items that invite a response, but I get none.
